

Public Notice of Tax Increase - Millage rate to remain unchanged for 2025.

The City of Grayson has tentatively adopted a 2025 millage rate which will require an increase in property taxes by 4.58 percent.

All concerned citizens are invited to the public hearing on this tax increase to be held at the Grayson City Hall, 475 Grayson Parkway, Grayson, GA 30017 on August 11, 2025 at 10:00 am.

Times and places of additional public hearings on this tax increase are at City Hall, 475 Grayson Parkway, Grayson, GA 30017 on August 18, 2025 at 10:00 am and at the Grayson Senior Center, 485 Grayson Parkway, Grayson, GA 30017 on August 18, 2025 at 6:30 pm.

This tentative increase will result in a millage rate of 1.985 mills, an increase of 0.087 mills. Without this tentative tax increase, the millage rate will be no more than 1.898 mills. The proposed tax increase for a home with a fair market value of \$475,000 is approximately \$16.53 and the proposed tax increase for non-homestead property with a fair market value of \$450,000 is approximately \$15.66.
